

# **PROVIDE FOR FAMILY**

Many people choose to leave everything they have to their family and loved ones. On the surface, it makes sense. However, the reality is that your estate may be taxed, perhaps more than you realize. Even if there is no estate tax due, there may be income tax that will be paid on certain assets flowing to your beneficiaries. A careful calculation can demonstrate that a small percentage of your

estate left to charity still leaves enough for you to support your loved ones while reducing, and in some cases, even eliminating the taxes to be paid. A financial advisor can help make sense of this based on your situation.

If you are considering a gift to a nonprofit organization in your estate plan, one simple solution is to name that organization as a beneficiary or partial beneficiary of your retirement accounts. This allows you to leave other lesstaxed assets to your family and loved ones. You may also want to consider naming a nonprofit organization as the beneficiary of your life insurance policy or other financial accounts. There are three simple steps to making a beneficiary gift to a nonprofit:

1. Request a "change of beneficiary" form from your financial services provider.

2. List as beneficiary(ies) the nonprofit(s) you wish to include.

3. Notify the nonprofit(s) so they can thank you or include you in their legacy society.

# WHAT IF?

What if you haven't decided which charities to support in your estate? What if that favorite organization no longer exists when it is time to distribute your assets? What if you don't want to give a lump sum to charity, but you would rather give a stream of gifts over years? These situations and others are when the Community Foundation can serve as a conduit for your generosity. With the help of your advisors, you can name the CFWA as the beneficiary of the charitable portion of your estate. We can then work together over time to refine decisions and prepare related documents to honor your evolving wishes without incurring legal expenses.
