A MESSAGE FROM GLENN

Twenty-five years ago a group of visionaries in Tuscaloosa saw a need in West Alabama and set out to address the problem. There are hundreds of nonprofit organizations in West Alabama and each one addresses a need in the community. But who is there to address the needs of the nonprofits? The Community Foundation of West Alabama was established with two goals in mind, to help each of our area nonprofits and provide a service to our citizens.

As we turn 25 years old this year, here is a snapshot of your Community Foundation.

Over 130 funds under management

Over 33 Million Dollars in Donations

More than 25 Million Dollars in Gifts to Charitable Causes

The CFWA provides many benefits to individuals and agencies.

Services provided by the CFWA are:

Agency Accounts – These accounts are offered to area nonprofits to help them secure the best return on their investments. If a charity has some funds with no immediate plans for use, those funds can be pooled with the larger pool of financial resources at the CFWA to benefit from professional asset management. The nonprofit organization retains ownership and control of its funds.

Endowments – These funds are often set up with a long-range plan, with the goal of supporting community works far beyond our lifetimes. The corpus of the fund is invested for perpetual funding of donors' charitable interests.

Donor Advised Funds – Our most popular fund choice gives the donor the benefit of immediate tax advantages. The fund can then be used anytime in the future to recommend gifts to the charity of choice.

ELIJAH ODOM CROW MEMORIAL ESTABLISHED

Perhaps the greatest source of grief for a parent is the loss of a child. There have been many examples of this in our community. Just last year we wrote about Laney's Legacy. This fund was set up to honor the memory of Laney Greene.

Brad and Ashley Crow experienced a tragedy in 2019 when their 3-year-old son, Elijah, was taken in a tragic accident. In the months that followed, as they dealt with their grief, they were given the following advice by Rick Burgess who himself had lost a son under similar circumstances in 2008. He asked Brad and Ashley what they wanted Elijah's legacy to be? Specifically, would his death mar their lives with darkness and grief, or would it be an occasion to allow Christ to use it for good?

Brad and Ashley are people of faith. They thought it was fitting that Elijah's birthday was August 28 (8/28) calling to mind the verse from Romans 8:28.



Wishing to honor the memory of Elijah in a positive way, Brad and Ashley set up the Elijah Odom Crow Fund at the Community Foundation. The monies will be used in ways to honor the memory of their young son. More information can be found on their website at www.crowcrew6.com.


