Having a donor advised fund is like having a mini private foundation without all the hassle. Ms. Olen adds, "Another reason: Perhaps the account holder just wants the tax deduction, and doesn't feel like selecting a charity at the moment. These funds allow people who earn more money in one year than another to





SMALL BUSINESS RELIEF EFFORTS



Partnering with the Chamber of Commerce, a total of 300 businesses in West Alabama were helped with our Small Business Relief Funds. A total of \$1.25 Million was awarded to local businesses. Glenn is pictured with Jim Page and Barkley Garrett of the Chamber.

Glenn noted, "My faith in our local community was strengthened as I watched the small business community come together in support of one another. Just one example will suffice. One of our local businesses received a grant from our Small Business Relief Fund early in 2020. The grant helped the business survive and recover. Later in the year, we received a donation from this business for the SBRF. Their desire was to help others as they themselves had been helped."

YOUR COMMUNITY AND YOUR FOUNDATION

When people think of the Community Foundation, what comes to mind? I suspect in many cases it is that this organization is only for those with deep pockets and great resources. That is a misconception. This organization exists because of donors like you. People who care about West Alabama. People who see a problem and want to help. Between concern and hope, a check is written.

It is a fact that 35% of our accounts contain less than \$25,000 with many under \$10,000. The services we provide are very helpful to the donor regardless of income bracket.

Currently our 16 agency accounts hold about 30% of our total funds. These accounts are designed to help our nonprofits invest their funds. In 2020, these funds produced a return of about \$750,000 for our partner agencies. If you are part of a nonprofit, this might be of interest to you.

We manage 10 Scholarship funds that award 16 scholarships per year. This is an excellent way to honor one's family while supporting education. The recipients each year are grateful for the support. To date, about 275 of these scholarships have been awarded.

Endowments are permanent sources of support. The 8 endowments managed by the CFWA help fund regular grant cycles. Endowments are great tools to include in estate planning. The permanent funding can support one's charitable interests even after you are gone.

The Donor Advised Funds are our most popular accounts. They make up about 70% or our accounts. The convenience of these funds makes them very attractive to donors and they offer several tax advantages.

The CFWA currently manages over 100 accounts with \$17 Million in assets. We would love to discuss our services with you and add you to our family.
