## **CFWA STEPS UP TO HELP SMALL BUSINESS**

COVID-19 will forever be associated with the year 2020. The term "unprecedented times" has been overused but it is an apt description of what our community, state, and nation has endured. Times have been tough. But we are a tough-minded people and we will survive. It does however, illustrate that we have a great community.

In mid-March when the governor ordered the closure of non-essential businesses and schools, our lives changed dramatically. No sector of our community was affected more than the small business community. Within hours of the closure, the CFWA had partnered with the Chamber of Commerce of West Alabama to implement the Small Business Relief Fund.

It was presumed that help would come from the Federal and State level, and it did so in the form of the Payroll Protection Plan and the Economic Injury Disaster Loan. Yet we knew those would take time, and time was something our small businesses didn't have. We were concerned about the "mom and pop business" that would not be able to survive the wait. We knew they needed help in order to meet payroll or pay rent immediately.

The Chamber and the CFWA both went to work to raise funds and address those immediate needs. To date about 300 businesses have received \$1.25 million dollars in assistance. We suspect some of these businesses would not have survived without this immediate assistance.

We were concerned about the "mom and pop business" that would not be able to survive the wait.

We are especially thankful to Mayor Walt Maddox and the City of Tuscaloosa for directing \$1 million to the SBRF as part of the Restart Tuscaloosa program.

The CFWA is especially thankful to the Chamber for their assistance in administering this program. Jim Page, President and CEO of the Chamber comments, "Without partners like the CFWA, initiatives like the SBRF would simply not exist. The CFWA has been committed to caring for the citizens of our community for over two decades, and their support for our small business community is unmatched."

Many recipients have expressed their gratitude with comments like:

"Your support has had a tremendous impact on our ability to maintain our payroll, address necessary repairs and purchase supplies to continue our cleaning business."

"It is my intention as a small business to weather this storm. Your grant is a blessing."

"This pandemic has changed our daily lives. We had to close our doors for a bit but the money you gave us has helped keep us afloat."

The response to this fund is a testament to the generosity of our community. One of the more encouraging things to come out of this is how the business community has stepped up to help one another. While many businesses have suffered, there are some that have been largely unaffected. We have received very generous support from some of these businesses in order to help their struggling brothers.

#### A MESSAGE FROM GLENN

I hope you each have survived this most unusual year. Resilient is a word frequently used by my favorite football coach. We are a resilient community, and we will survive. There have been many changes. While many things have changed, some things remain the same.

As a CEO of a nonprofit, I can speak to the fact that it is during difficult times that the requests presented to the charitable community are the greatest. All of our nonprofits have struggled during this time. It is a catch-22 situation, because during the time when their resources are being drained the fastest, it is also the time when their donations and income begin to fall off.

Utility bills continue to come in. Rent is expected to be paid. Salaries continue. While the small business community was helped with the Small Business Relief Fund, the nonprofit community was not eligible for those resources. I urge you to continue to support your local charitable works.

The CFWA has continued to support our local nonprofits. To date we have disbursed

about \$500,000 this year to our charitable community. This amount, along with our \$1.25 million to the SBRF, means we will likely distribute \$2 million by years end.

The CFWA is also a nonprofit. I am thankful for the

support we have received during this time. Even with the cancellation of our Pillars event, many of our Pillars sponsors have told us to use their 2020 support this year for our current needs, with the understanding that they will be back in 2021 with their normal support.

#### FLEXIBILITY OR PERMANENCY?

With the unpredictability of today's world, many people are interested in sharpening the ways they manage their charitable giving. If you choose to work with the CFWA for your giving plans, it is no longer an either-or situation. You can have both elements of flexibility and permanency in your plans.

By opening a Donor Advised Fund, it allows you to make a charitable contribution, receive an immediate tax deduction and then recommend grants

from the fund over time. Donors can contribute to the fund as frequently as they like and then recommend grants to their favorite charities whenever makes sense for them. This is a simple and flexible way to support a variety of charitable interests over time.

When thinking ahead, many of us recognize that our regular gifts each year will be missed once they can no longer be made. To continue the pattern, you could create a permanent endowment fund in an amount that is 25 times the amount you currently give each year. For example, a person who gives \$1,000 annually can endow these contributions by creating a permanent fund of
