ENDOWMENTS PROVIDE PERPETUAL SUPPORT

O: What are endowments?

A: An endowment fund is a permanent, self-sustaining source of funding. Endowment assets are invested. Each year, a portion of the value of the fund is paid out to support the fund's purpose, and any earnings in excess of this distribution are reinvested to build the fund's market value. In this way, an endowment fund can grow and provide support for its designated purpose in perpetuity.

Q: Why should I consider creating an endowment?

A: When you establish an endowment fund, you create a permanent legacy of support for your chosen charitable projects. It can feed the needy, support animal rescue work, maintain a cemetery, provide scholarship support, and the like.

Q: How much money does it take to start an endowment? A: At the CFWA, a minimum of \$10,000 is required.

Q: What else is needed?

A: An endowment agreement, which permanently defines the purpose of the fund. We will discuss your preferences and suggestions with you as we create the agreement, and the document also outlines standard procedures for managing endowment funds.

Q: Whose name is on the endowment?

A: You can name an endowment for yourself, your family, your friend, your company – the choice is yours.

Q: What if I want to give to an existing endowment?

A: There may be an endowment at CFWA that reflects your interests and to which you can add your support. Gifts of any size are welcomed. Also, many donors who have endowment funds at CFWA continue making gifts to them over time.

Q: How is the distribution from an endowment calculated?

A: We have flexibility to make spending calculations based on your goals. We consider the frequency of awards, a specific award amount you may like to see made, and plans for growth of your endowment when making spending decisions.

Q: How do I find out about my endowment after I have made my gift?

A: CFWA will send quarterly reports detailing the value and use of your endowment fund. When you establish an endowment, you begin a new relationship with CFWA, and we will always keep you, your company, or your family updated on what your gift is making possible.

Q: What if my endowment fund provides a scholarship?

A: You may participate in the selection process and be present when the awards are made. You can personally deliver checks for spending from endowment earnings, and rest assured the activity will continue in perpetuity when you are no longer able to be involved.
