THE APPEAL OF DONOR ADVISED FUNDS UNDER THE NEW TAX LAW



Sydney Cook is a local tax attorney. He is an advisor to a personal Donor Advised Fund held at the CFWA. he 2017 Tax Cuts and Jobs Act has been something of a mixed bag for high-net-worth families. The 39.6% to 37% reduction in the top individual tax rate and the increased threshold to enter the highest tax bracket for married couples (filing jointly) were two of the benefits that came out of the December 2017 legislation.

However, the new law also contains some challenges for high-income taxpayers – notably, the new \$10,000 aggregate annual cap on deductions of state and local income and real estate taxes. If there is a silver lining, however, it is that more households could be able to utilize charitable gift "bunching" in order to increase their total itemized income tax deductions over a multi-year time frame.

Under the new law, charitable gift "bunching" may prove to be beneficial to those whose non-charitable itemized deductions fall below the new higher standard deduction (\$24,000 annually for persons married filing jointly). "Bunching" involves consolidating tax-deductible charitable contributions that would normally be made over multiple years into making them in a single tax year. In the consolidated year, the donor contributes to a charitable giving vehicle, such as a donor advised fund (DAF) with a sponsoring nonprofit, and receives an immediate tax deduction through itemizing deductions

on his or her federal tax return.

The Community Foundation of West Alabama (CFWA) is a local nonprofit that offers donor advised funds. After creating a personal DAF account, the donor may recommend grants from his or her ...the donor benefits from being able to itemize deductions in the year of the aggregate contributions...

DAF to qualified charities in desired amounts and frequencies over several years. While the higher standard deduction would still apply in certain years, the donor benefits from being able to itemize deductions in the year of the aggregate contributions, which could improve total income tax efficiency over time.

Before implementing a charitable gift bunching approach, however, it is important to examine the factors specific to each person's financial situation. In all cases, families should consult with their tax advisors.
